FIREWOOD POLICY



Attention*** Use caution when transporting wood due to the potential transport of non-native pests. The Spotted Lanternfly is a non-native and invasive pest that impacts native plant species. Please visit the PA Department of Agriculture website for additional information and to print a Spotted Lanternfly Checklist for Residents. It is good practice to burn firewood as close to the source of purchase as possible.

Firewood Best Management Practices

Important Rules

- All permit holders must enter through the FTIG Main Access point located on Fisher Ave.
- Entry to the wood yard is at your own risk; the department assumes no responsibility for damages or loss for any reason.
- Firewood shall be used for personal use and not resold.
- Firewood is screened based off location of standing wood to be free of foreign objects such as metal, nails, or ammunition, however, the department does not guarantee the wood to be free of foreign objects.
- Firewood yard supply and species fluctuate, and availability is not guaranteed.
- When purchasing wood electronically, the date of purchase should be the same as when you cut the wood.
- Daily maximum=Unlimited
- Annual maximum=Unlimited
- All vehicles and trailers entering the woodyard must be designated during registration.
- Any disputes will be settled by the Department's representative. All decisions by the Department's representative are final. Abuse of this program or any violations of the program policies will be grounds for the customer's removal from the program.
- The Department reserves the right to refuse access to the firewood yard for any reason at any time.

- Firewood is in log form in 8 to 12-foot lengths. Hardwood species which include oak, birch, Yellow poplar, and ash. Customers will be responsible for cutting and loading their own firewood.
 - ** It is preferred that all users register and purchase wood electronically. If you are unable to register and pay electronically, please see the Environmental Office for non- electronic registration and payment.

- Current fees collected for firewood are:
- Cargo area or trailer
 - 5.5' or less: \$20
 - Between 5.5' and 8': \$25
 - **8**': \$30
 - **1**0': \$45
 - **1**4': \$65
 - 18': \$120
 - **>**18': \$150

Note:

- Log Splitters are allowed. No other mechanized equipment such as skid steers, tractors etc. will be permitted in the yard.
- Customers will receive a receipt that should be available upon request.
